- 2) Any and all loss, damage, liability, legal action or claim of any nature arising out of the boat or camping trailer owner's use of The Club facilities or The Club property; and
- 3) In the event of any damage or injury to The Club facilities or property arising from active or passive acts, omissions or negligence of the boat or camping trailer owner, all expenses incurred by The Club to repair or restore The Club facilities or property shall be paid by the boat or camping trailer owner who caused the damage.
